The 17th edition of the **International Conference on e-Society** was held in Utrecht, The Netherlands, during **11 – 13 April, 2019**.

This conference was organized by the International Association for Development of the Information Society (IADIS) and co-organized by University of Applied Sciences.



This event focused on the main areas within Information Society. It covered both the technical as well as the non-technical aspects of the Information Society. The conference broad areas of interest were: e-Government / e-Governance, e-Business / e-Commerce, Technology and Society, e-Learning, New Media and E-Society, e-Health, Information Systems, and Information Management.



The e-Society 2019 had 174 submissions from more than 29 countries. Each submission was anonymously reviewed by an average of 4 independent reviewers, to ensure the final high standard of the accepted submissions. Out of the papers submitted, 32 received blind referee ratings that signified acceptability for publication as full papers (acceptance rate of 18%), while some others were published as short and reflection papers and posters.
